1. Results of simple linear regression analysis

The motivation variable coefficient is 0.605, meaning that every time the motivation variable increases by one unit, employee performance increases by 0.605 units. To test the level of relationship between the independent variable (X) and the dependent variable (Y), the t test and f test are used. Test to determine whether the independent variable or independent variable (X) partially influences the dependent variable (Y), and the f test to determine whether the independent variable independent variable (X) partially influences the dependent variable. The t test is carried out by comparing the calculated t with the t table using the following criteria:
